Copper Lake currently has two properties in Ontario –the Marshall Lake property and the Norton Lake property.

The Company has the option to earn an initial 50% interest in the Marshall Lake property, with the right to increase its interest to 75% by incurring such additional expenditures as are necessary to take the project to a bankable feasibility stage. To date, the Company has earned a 37.5% joint venture interest in the Marshall Lake property. The Company intends to focus its near term efforts on the continued development of the Marshall Lake property, which is an advanced exploration stage copper, silver and gold project located 120 km north of Geraldton, Ontario, via a good all weather gravel road from Hwy 11/Trans Canada Hwy, and 22 km north of the main CNR rail line.

The Company currently holds a 60.7% interest in the Norton Lake property, which has a NI 43-101 compliant resource.
